Definition of HIB

"Harassment, intimidation, or bullying" means any gesture, any written, verbal or physical act, or any electronic communication, as defined in N.J.S.A. 18A:37-14, whether it be a single incident or a series of incidents that:

Is reasonably perceived as being motivated by either any actual or perceived characteristic, such as race, color, religion, ancestry, national origin, gender, sexual orientation, gender identity and expression, or a mental, physical or sensory disability, or by any other distinguishing characteristic;

Takes place on school property, at any school-sponsored function, on a school bus, or off school grounds, as provided for in N.J.S.A. 18A:37-15.3;

Substantially disrupts or interferes with the orderly operation of the school or the rights of other students.



Conflict vs. HIB

Conflict

- "Mutually" competitive or opposing action or engagement.
- Includes disagreements, arguments and fights.
- A normal part of growing up and of life.

<u>HIB</u>

- HIB is one-sided.
- One or more students are victims of one or more person's aggression, as it applies to the HIB definition under the ABR.
- The intent is to physically or emotionally hurt someone.



Self Assessment

Each school, through its School Safety & School Climate Team, is required to evaluate its implementation of the ABR from July 1, 2023 through June 30, 2024 by using the Self-Assessment. The Self-Assessment tool includes eight core elements that address the ABR requirements for schools.
